## Local 34 and 35 lead the way at HERE Convention

From July 15-19, Locals 34 and 35 representatives attended a rocking HERE International Convention, an event held once every 5 years. Local 34 President Laura Smith said that it was an "amazing experience. The convention focused on organizing and was really all about the important work of

rank and file members and member participation."

The convention opened with local union members from all across the country describing the victories HERE locals have had since the last conference in 1996. Alexis Flint (Local 34) and Mark Wilson (Local 35) described the victories achieved in New Haven. Wilson said the conference was "wonderful and inspiring."

Don Frigo (Local 34) explained, "To me the highlight of the convention was seeing that our contract fight and everyone else's is part of a bigger struggle nationwide for working people to better themselves." Laura Smith and Bobby Proto gave a presentation on Local 34 and 35's history and our strategy for creating an alliance with the hospital workers and GESO for greater organizing and bargaining power at Yale.

Our international union elected its new officers at the convention. Our locals' presi-

dents Proto and Smith were part of the nominating team for John Wilhelm's position as President of HERE. They described Wilhelm's roots with Local 35 and Local 34 in the 1980s and how he still continues to inspire the unions at Yale. Karl Lechow, who has been active in the New Haven organizing for years, was elected Director of Organizing.

Laura Smith said, "Lechow and Wilhelm's elections made me

feel proud to be a part of this union."

## Activism Sparks Pension Increase for pre-1996 Retirees

We all know how important union solidarity is in the effort to improve our working lives. Recently, our retired sisters and brothers have gotten Yale to begin improving the pension for older retirees, by standing together with Locals 34 & 35. The increases are just a start, and do not apply to recent retirees, but they do reveal that Yale is willing to negotiate pension increases.

Organized in 1998, the Yale Unions Retirees Association (YURA), is composed of Local 34 and Local 35 members who are now retired. The mission of the group is to further the interests of and to protect the rights and benefits of Yale retirees. According to Doris Rogan, former Senior Administrative Assistant in Geology & Geophysics and a YURA leader, there are currently about 1,100 Local 34 and Local 35 retirees.

About 30% of all Yale retirees receive less than \$300 per month in their Yale pension.

Members of YURA have been organizing rallies and petitions to support a pension increase. They have also been present in increasing numbers at the October and April actions by the Federation of Hospital and University Employees. The retirees even distributed a flyer about the pension to alumni after George H. W. Bush spoke on April 21 at the Tercentennial event. Many retirees were front and center at the Yale unions' vigil during the 2001 commencement ceremonies.

Finally, this past June, the University reacted to YURA's efforts and announced an adjustment to the pension, effective July 2001. The size of one's increase depends on one's year of retirement:

 1988: 20% increase

 1989: 18%

 1990: 16%

 1991: 14%

 1992: 12%

 1993: 10%

 1994: 8%

 1995: 6%

 1996 - present: 0%

# Mayor DeStefano works for better parking on Yale campus

Last May, the City Plan Commission held a public workshop on Yale's parking plans. Since that time, Mayor DeStefano and his administration have worked to improve parking across the Yale campus.

First, the mayor established a "task force" to address the problems parking around the Yale medical area. He has assigned both Local 34 researcher Antony Dugdale and District 1199 research Grace Rollins to the task group.

The task force has been charged to come up with both short-term and long term solutions. The State of Connecticut is expanding the Route 34 connector out towards Ella T. Grasso Boulevard, scheduled to begin next Spring or Summer. The construction will eliminate parking under the Air Rights garage, in Lot 2, and in the other lots in the median between the Frontage roads. The task force will develop plans that minimize the disruption to the Yale parkers who use those spaces.

The task force is also charged to develop long-term solutions; current discussions include the possibility of additional parking structures.

The mayor's efforts also extend to the Central and Science Hill campuses. In a let-

ter dated August 16, 2001, Mayor DeStefano writes: "Yale has a responsibility to the residents of this City as well as its employees to make adequate parking a part of its expansion plans. With a new medical building, new arts building, and new bioengineering building, Yale is spreading outbut without consideration for residents or employees. In addition to being inadequate in terms of accomodating the demand, most of the parking Yale provides is too far from the workplace, and not within zoning code ordinance requirements."

The mayor continues: "Yale should beand will be-held accountable. The City will demand that Yale adhere to the zoning code ordinance, and the City Plan Department will require that Yale modify its facilities development proposal to include parking plans that are acceptable and accomodating to all who will be impacted."

The mayor's letter concludes, "Yale prides itself on its status as a premier higher learning institution. But the university's measures to enhance learning opportunities for students should not be at the expense of everyone who lives, works, or visits New Haven. Improving life for the benefit of all should be the first and most important lesson."

Workers who retired in September 1996 or later receive no increase under this initiative.

Many of our retired sisters and brothers helped organize Locals 35 and 34, and their continued hard work and solidarity on behalf of working people should make us all proud.

Doris Rogan explained why she is active in the retirees association: "Yale would not be the great institution it is if not for the loyal dedication and hard work of both its former and current employees. As workers and union members, we learned the value of sticking together, and that lesson is just as vital now that we're retired."

## News in brief

#### Local 34 Contract Surveys

To date, about 1300 surveys have been conducted in the Local 34 bargaining unit. Besides substantial raises, which seems to be first on most lists, the next 4 items our members would like to see improved pension/retirement benefits, parking, health benefits, training/promotion opportunities, respectively. Interestingly, these items were ranked as #1 in importance in the same order. The survey is on-going.

#### Local 35 wins \$20,000

Local 35 won another year of funding for its acclaimed "Women's Program". The union will receive \$20,000 to allow union members to take time off of work and receive leadership training. Contact Meg Riccio for details.

#### **Our Unions in London**

On July 6, our British allies leafletted in protest outside St. Paul's Cathedral in London, while Yale held its European Tercentennial celebration inside.

The event was reported in Britist newspapers The Guardian and The London Times Higher Education Supplement. Leafletting is not the norm for union activity in England, but our allies reportedly loved it and are looking for opportunities to try it again. Just as Yale is "everywhere", so are unions in solidarity.

#### 1199 Strike Fund Collection

At the last Local 34 Membership meeting, \$500 was collected to donate to the 1199 nursing home strike fund. That money will be matched by Union funds, making the donation a total of \$1,000.

## A note on the mayoral primary

Neither Local 34 nor Local 35 have ever endorsed a candidate in a mayoral primary. In the upcoming New Haven mayoral primary on September 11, we will continue in that tradition, and will not take sides.

Both candidates are strong supporters of workers rights at Yale, and both candidates are our friends. Both candidates have supporters among our members.

Both candidates spoke before an assembled group of union leaders on August 8. Both made clear their willingness to work hard for the interests of working people.

We encourage all our members who are "Democrats" to become active in the primary campaign, to work for the candidate they believe to be best for New Haven, and to vote on Tuesday, September 11.
