Not Separate, Not Equal:

Yale University and Yale-New Haven Hospital

Yale University and Yale-New Haven Hospital are deeply integrated. The hospital earns enormous revenue and prestige by virtue of its relationship with Yale. The University finds a patient base for medical research at the hospital, and earns millions of dollars in revenue through the provision of physician services to hospital patients.

Shared Governance:

- The by-laws of the Hospital and its parent corporation (Yale New Haven Health Services Corporation)
 guarantee the University seats on both Boards of Trustees. The University directly controls roughly a third
 of the board of the hospital through officers and faculty. It's a one-way street, though -- the Hospital has no
 representation on the Yale Corporation, the governing board of the University.
- Most Yale Medical School Department heads hold joint appointments as chiefs of corresponding services in the hospital.

Financial Integration:

- The University is the direct grantee for all federal grant money that flows to the hospital. Yale University
 received \$275 million in research grants from the federal government in fiscal 2000, 77% from the National
 Institutes of Health for medical research. The Hospital received no direct NIH grants at all. Yet, more than ten
 percent of the hospital's revenue stream (over \$52 million or 11.4% in FY99) is from "Recovery of expenses
 from grants and other institutions."
- The third largest source of income for the University is medical services (\$201 million in Fiscal Year 2000). A significant portion of that is from physician services provided to patients seen while they are admitted to the hospital.
- The University signed a sweeping new agreement with the Hospital system parent corporation in 1999. The hospital will manage relationships with payers for the Medical School doctors' Yale Faculty Practice.

Joint Operations:

- University Medical School employees work side by side with Hospital employees in many departments, doing the same work, supervised and directed by employees of both entities.
- The University told the Connecticut Supreme Court that it is a joint employer with the Hospital of interns and residents. The Court granted Yale a new trial in a case in which an intern suing the University had received a multi-million dollar damage award.
- The University has a strong voice in the operations of Hospital Departments. Yale New Haven Psychiatric Hospital, the hospital's psychiatric wing, is jointly managed by a leadership "team" consisting of a Managing Director employed by the hospital's corporate entity, and a Clinical Director employed by the University. They share responsibility for planning, budgeting, staffing and operating the service.

University Dominance:

- Yale University has guaranteed representation on the Yale-New Haven corporate boards of trustees.
 University President Richard Levin, Secretary Linda Lorimer, Vice President Bob Culver and Yale School of Medicine Dean David Kessler all serve on the hospital board. The Hospital does not have representation on the University's governing body, the Yale Corporation.
- The University has nearly ten times the hospital's wealth.
